### Sec. 1 MEMBERSHIP

The privileges and requirements of the four classes of membership are as shown in the following table.

Guests may attend any club function but have none of the privileges of membership as shown in the table.

(1) At least one member of the family must hold a valid amateur radio license.

(2) Family members who do not hold a valid amateur radio license shall be Associate class members.

Anyone seeking membership in the SLAARC shall submit a complete and accurate application form to the Treasurer with the required dues. Membership will become active upon acceptance and approval of the application form and dues by the Treasurer.
